**\* SURCHARGE (S/C):**

- New York State has passed legislation mandating the imposition of a Surcharge.
- Effective July 26, 2013, the Surcharge is **\$93.00** per offense, not to exceed \$356.00 for MOVING violations, and **\$63.00** on EQUIPMENT violations.

**FAILURE TO RESPOND:**

Failure to respond to a summons on or before the return date may result in one or all of the following:

- **SUSPENSION** or **REVOCATION** of your driver's license for each charge with a N. Y. State mandated surcharge of **\$70.00** to lift each suspension and;
- Additional penalties and/or a money judgment pursuant to § 1806-A of the Vehicle and Traffic Law and;
- A **WARRANT** being issued for your arrest.

**PLEA OF GUILTY BY MAIL:**

The Court has the right to reject any guilty plea by mail and order that you personally appear and to fix a different fine than that set forth on the Schedule.

**PAYMENT OF FINES BY MAIL:**

All fines must be paid by **CERTIFIED CHECK, BANK CHECK** or **MONEY ORDER** payable to "**FLORAL PARK VILLAGE JUSTICE COURT**". **\*\*\* NO PERSONAL CHECKS WILL BE ACCEPTED \*\*\***

**IF YOU DECIDE TO APPEAR IN PERSON:**

- Please be advised that all fines must be paid by **CASH, CERTIFIED CHECK, MONEY ORDER, VISA** or **MASTER CARD**. **NO PERSONAL CHECKS WILL BE ACCEPTED**
- All cases are conferenced by one of the Village Prosecutors and as such, ALL parties are to arrive at 7:00 PM to conference your case before the Court session commences.
- Persons Under 18 Must Appear in Person on The Return Date and be accompanied by a Parent or Guardian.

If the offense you are charged with is not enumerated above, you may contact the Court at the 516-326-6325 for fine amount, or whether a Court appearance is mandatory.

Failure to comply with the foregoing may result in your plea not being accepted and the case being adjourned to another evening.
