Trustee Fitzgerald reported that this week the Floral Park Fire Department lost a long-time member, Ex-Captain Thomas Quigley. Tom was an active member of the department for 26 years, in which he held many positions. Trustee Fitzgerald said he had the pleasure of serving with Tom while they were both working on the Parking Committee. Tom was also a member of the United States Marine Corp having served several tours in Vietnam.

Recreation Center

Trustee Longobardi invited everyone to the tree lighting ceremony at the Recreation Center on Friday, December 16th at 7:30 pm. Cookies and hot chocolate will be served!

Building Department

Trustee Pombonyo reported that the Architectural Review Board (ARB) has continued to consider the applications submitted by Questus South Tyson to develop the former Koenig's properties. Plans call for a total of twenty six 1 and 2 bedroom apartments, 5 of which would be located on the second floor of the Koenig's building and twenty one of which would be located on three floors above a parking level at 77 South Tyson, on the opposite side of the street. The parking lot across from the Koenig's building will continue as a parking lot, under the Questus proposal, with an entrance on South Tyson and exit on Mayflower Place, adjacent to the lot. All entrances and exits to and from the parking area at 77 South Tyson will be on Mayflower, not South Tyson, as per the proposal. Restaurant use on the first floor of the Koenig's building is currently planned. The Building Department Superintendent Stephen Siwinski, and the ARB continue to make recommendations, approvals are pending, and new proposals will continue to be considered by the ARB.

Centennial Gardens

Trustee Pombonyo reported that AHRC volunteers worked tirelessly throughout 2016 to maintain and beautify Centennial Gardens. All were honored at a recent luncheon at the Recreation Center. At this week's installation of the AHRC Board of Directors, President Paul Giordano thanked all in the Village of Floral Park for hosting the volunteers and supporting this valuable AHRC work readiness and community service experience.

Department of Public Works

Trustee Cheng reported that the Department of Public Works has decorated the Village for Christmas. DPW continues to pick up the leaves and the Superintendent of Public Works, Stephen Siwinski, says we are ready for snow! Trustee Cheng thanked DPW for preparing Memorial Park for the annual tree lighting which took place on December 9th. The festival, sponsored by the Floral Park Chamber of Commerce and the tree lighting sponsored by the Floral Park Junior Woman's Club, was a great event.

Mayor's Report

Mayor Tweedy said that the tree lighting on December 9th was a wonderful event and he thanked the Floral Park Chamber of Commerce and the Floral Park Junior Woman's Club for all their hard work. For the first time, it was more than just a tree lighting; it was a festival in which vendors participated and Our Lady of Victory and the United Methodist Church were also present. There was a large turnout and a great time was had by all.

Police Department

Mayor Tweedy reported that a speed sign has been installed on Covert Avenue and is being strictly enforced by the Police Department. Mayor Tweedy thanked Senator Jack Martins for helping us get the sign. The Mayor said he hopes to be able to get four more signs to put throughout the Village. However, the cost of each sign is approximately \$10,000. This sign was also used during the Belmont Stakes and was a useful tool in controlling traffic.
