Mayor Tweedy made the following comments regarding Local Law No. 05-2016:

'At the last Board Meeting, the Public Hearing was closed and this Board considered all the ramifications and has listened to the thoughts of our residents and members of our PBA. As I have already said but bears repeating, law enforcement is currently in the midst of a complex and challenging landscape that demands strong, ethical and courageous leadership. Police leaders are called upon to provide both management and leadership, build trust in the community and the agency, model ethical behavior on and off the job, develop upcoming leaders and guide internal change, among numerous other responsibilities.

As a result of developments during the past 15 years, Police Commissioners in the United States have become accountable to the public and elected officials for additional complex specialized law enforcement functions and responsibilities. In light of the many recent tragic police-involved shootings and deaths in custody including but not limited to Chicago, Illinois; Baltimore, Maryland; Cincinnati, Ohio; Ferguson, Missouri; North Charleston, South Carolina; and even here in Staten Island, New York, it has never been more critical and necessary to have an experienced law enforcement professional at the helm of any Police Department.

The future of policing involves developing proper organizational cultures, accepting that mistakes can be made and focusing on the correction of these mistakes before they become tragedies and/or law suits. The focus has also been on the issues that can impact the efficiency and effectiveness of a police agency, in addition to adversely impacting the taxpayers. Some of the potentially costly issues include combating sick leave abuse, the management and control of GML 207-c, and a culture of integrity above all else. This big picture focus has been part of the reality of a post-tax cap world, but also because it is the right thing to do. Development of a proper organizational culture can take years and requires experienced and dedicated chiefs and commissioners who are doing the right thing for the right reasons.

Mayor Tweedy then recited the revisions of Section 25-4A as amended as follows:

§ 25-4. Appointment; residency requirement.

- A. The Commissioner of Police shall be appointed by the Mayor of the village, which appointment shall be approved by the Board of Trustees and shall serve at the pleasure of the Board, all in a manner consistent with the provisions of the Village Law. The Commissioner of Police shall have at least the following qualifications and experience:
 - (i) A minimum of ten (10) years of progressively responsible experience (promotions in chain of command) in municipal law enforcement, which must include at least five (5) years in a command level position;

- (ii) A Bachelor's degree from an accredited institution; however, a Masters' degree from an accredited institution in Public Administration, Criminal Justice, Law Enforcement, Public Safety Management or related field shall be preferred; and
- (iii) Such other and further qualifications and experience as the Mayor and Board of Trustees may specify via resolution.

Trustee Fitzgerald then offered Resolution No. 2016-283 adopting Local Law No. 05-2016 which amends Section 25-4(A) of the Code of the Incorporated Village of Floral Park; and

Whereas, the Village of Floral Park held two public hearings on November 1, 2016 and December 6, 2016; and

Whereas, the public had the opportunity to have their comments placed on the record at both public hearings; and

Whereas, proposed Local Law No. 05-2016 was revised upon review of public comments by examining the transcripts of the two public hearings; and
