

A regular meeting of the Board of Trustees was held on April 16, 2019 at 8:00 pm.

The meeting opened with a Pledge to the Flag. Present were Mayor Dominick A. Longobardi, Trustees Kevin M. Fitzgerald, Lynn Pombonyo, Archie T. Cheng and Frank J. Chiara, Village Administrator Gerard M. Bambrick, Village Clerk Susan E. Walsh, Superintendent of Public Works and Building Department Stephen Siwinski, Deputy Superintendent of Public Works Kevin Ginnane, Police Commissioner Stephen McAllister and Village Attorney John E. Ryan

Prior to the start of the meeting, Mayor Longobardi asked for a moment of silence for John Tymecki, an employee at the Department of Public Works, who died last week. Please keep him and his family in your prayers.

Mayor Longobardi called upon outgoing Fire Chief David Maickel to present his annual report to the Mayor and Board of Trustees. Chief Maickel read his annual report as follows:

‘Mayor Dominick Longobardi, Deputy Mayor Kevin Fitzgerald, Trustee Dr. Lynn Pombonyo, Trustee Archie Cheng, Trustee Frank Chiara, Members of the Village Administration, Chiefs, Members of the Department, Residents and Guests.

I stand before you tonight extremely honored and humbled as Chief of the Floral Park Fire Department to give my final report for the year 2018-2019.

This is the status of our department:

Membership:

The Department currently has 182 members consisting of the following

Active membership is 151 including 109 firefighters and EMS, 25 Ex-Chiefs, 4 Honorary Chiefs, 13 Probationary members

28 Associate Members
3 Chaplains

This year we swore in 8 new members and had 6 resignations.

Alarms:

For the year:

EMS calls:	905
Fire Calls:	224
Auto accidents:	41
Hazmat/Hazmat related:	8

Total calls: 1,305

This year total fire loss is approximately \$125,000.00.

Training:

From the first moment we are sworn in, hands-on training begins and never stops. All firefighters participate in monthly drills as well as many hours of hands-on training, and annual department operations training at the fire academy in Bethpage. On the EMS side, the commitment is just as great, if not greater. Our EMTs put in hundreds of hours in the classroom as well as take a NYS test just to get their certification. Each year they spend numerous hours at continuing medical education classes as well as regular drills. All members participate in periodic department drills, drills with other departments, an annual MOBEX drill where we interact with FDNY and an annual battalion drill in Nassau County. This year our members accumulated 4,918 man hours of training; a testament to their professionalism and dedication. Thank you to Chief McAllister, Chief

Naughton and their committee for all their hard work and dedication to the training program.

Probationary Training:

We have our specialized in-house program to train our new members on how Floral Park operates and get them familiar with our equipment. Thank you to Chairman William Hecker and his committee for all their hard work and efforts with our new members.

Purchasing:

This year there were 57 purchase orders and 148 vouchers processed. Thank you to Village Administrator/Treasurer Gerry Bambrick and Village Deputy Treasurer Kathleen Mack for all your help and assistance with our purchasing needs.

Medicals and Fit Testing:

Each year our members are required to take an OSHA medical and interior firefighters are required to be fit tested for their SCBA mask. Thank you to Chief McAllister and William Hecker for overseeing these and ensuring our members are current.

Radios:

Radio communications are an ongoing problem. We constantly strive to find solutions and improve on what is our most important piece of equipment: our ability to communicate. We were advised that a grant had been secured to purchase new portable radios. It is currently awaiting approval from Nassau County.

Work Orders:

This year, there were 59 vehicle work orders and 14 house work orders. Thank you to Superintendent Steve Siwinski, Deputy Superintendent Kevin Ginnane and all the Village mechanics for all your hard work and dedication to this.

Pump, Ladder and Hose Testing:

All ladders and hoses were tested as required. Any damaged hose was removed and replaced. All three engines had their annual pump test.

Explorers:

Our explorer program continues to thrive under the leadership of Chief Florio,

Ex-Captain Georke, their advisors and members. At this time, there are 11 active members and five advisors.

Parades:

The department participated in two parades this year: July 4th Stewart Manor parade and the Nassau County Parade in Hicksville.

Fire Prevention:

Our fire prevention is always ongoing through both inspection and education. Our formal inspection program has our members go business to business to inspect and review what if any hazards exist and point these out to the business owners. This also gives us the opportunity to learn what goes on in these businesses and preplan buildings for that unfortunate event should there be fire. All this information is then entered in our red alert system. This year the department conducted 363 inspections. Thank you to Chief Bennett for all your hard work organizing and overseeing this very important and time-consuming task.

The education side involves formal programs as well as everyday calls. When we enter a house or business, we are able to look and see if extinguishers and alarms are present, and see if they are up to date, and if they are being maintained. It is still all too often we enter a home and there are no smoke detectors and no carbon monoxide detectors present. We talk to the homeowners about this and stress the safety issues and need for them. We also conduct firehouse tours and welcome groups such as the Boy Scouts and Girl Scouts, school children, and also visit groups in town. We show them the equipment we have and how we operate, as well as provide handouts. This year we coordinated seven separate tours between schools and various community organizations. Thank you to Chief Dodson for all our efforts to make this a success.

None of this well-oiled machine happens without many people involved and I would like to take a moment to thank some people.

Mayor Longobardi and the Board of Trustees: Thank you for all you have done and continue to do to support us. It is greatly appreciated.

Commissioner McAllister: It has been a pleasure working with you and entire Police Department. Thank you to all your officers and staff for a great job and their support.

To Gerry Bambrick, Susan Walsh and the entire staff at Village Hall, thank you for all your hard work and help. You make the day-to-day things happen and it is very much appreciated.

To Chief O'Grady and Chief Wakely, thank you for all your hard work in the office, you guys are the backbone of the office.

To Chief Longobardi and Firefighter Paul Pinto, thank you for the hard work you do.

To Chief Bennett, Chief Naughton, Chief Florio and Chief Longobardi, thank you for all your guidance and showing me the ropes as I made my way up the line to Chief. It was a pleasure working with you.

To my staff, Sal, Pat, Mike and Jep. What a great year it's been! I can't thank you enough for all you did this year! I know you guys will continue to do a great job. I couldn't have asked for a better staff! Brian welcome aboard. I know you'll do a great job.

To my family, I'd like to thank my mother and father for starting me on this ride 49 years ago. My kids, Gianna and Nicholas, thanks for always dealing with me running out at the most inopportune times. And most importantly my Chief – my wife, Gina. Thank you for always supporting me and being my rock. I couldn't have done this without you! I love you guys.

Lastly, I would like to thank my warriors, you truly make this department the best there is. Your dedication and hard work shows in everything you do. I can't thank you enough for allowing me the honor of being your Chief. I will forever be honored. The Village is truly blessed to have you.

Belmont Park – Trustee Kevin Fitzgerald

Trustee Fitzgerald thanked all the residents who attended Senator Kaplan’s Mobile Office meeting at the Library this past Friday. Trustee Fitzgerald said that he and his fellow Board members plus many residents raised a multitude of issues which further informed the Senator of the significant issues that the project as currently proposed will present to Floral Park.

There is no set date for the ESD to release the FIS. The ESD Board typically meets once a month with their next meeting being on Thursday, April 18th. The agenda is released a day or two before the meeting. Trustee Fitzgerald called the ESD and, as of this afternoon, there were no Belmont related items on the proposed agenda; of course, that is subject to change. We will certainly let our residents know as soon as we hear a date and time when the ESD Board may vote on the FIS.

Public Works Department – Trustee Kevin Fitzgerald

Trustee Fitzgerald said that the Village is planting approximately 100 trees throughout the Village. We ask that residents take care of these new trees so that they can grow to their expected height and provide all the benefits that we have come to expect.

Police Department – Trustee Kevin Fitzgerald

Trustee Fitzgerald said that this week the Department released its 2018 Annual Report. It can be found on their webpage, Facebook page or Twitter page. Trustee Fitzgerald encourages all residents to take a few minutes to read through the document to get a better understanding of the services and superior job that our Police Department does.

Recreation Center and Pool – Trustee Lynn Pombonyo

Trustee Pombonyo reported that, following this past Saturday’s Floral Park Little League parade and opening day, our spring and summer sports season is in full swing. Come down to the Rec Center to cheer on our local athletes, young and older.

As we head towards the June 9th opening of the Village pool, watch for your copy of the Pool & Recreation book filled with registration information and pages of enjoyable summer activities for those of all ages at the Rec Center and Pool. Covert Avenue Chamber of Commerce – Trustee Lynn Pombonyo

Trustee Pombonyo reminded everyone that, as the partial closure of Covert Avenue north of Stewart Avenue is now underway, please continue to patronize our Floral Park and Stewart Manor businesses, and SHOP LOCAL!

Third Track Project – Trustee Archie Cheng

Trustee Cheng reported that of the 2,200 feet of support excavation wall construction on the south side of the right of way, approximately 1,300 feet has been completed. Approximately 15 feet remains until the Linden Avenue tunnel is reached.

We have been advised that the retaining wall should begin in the next two weeks.

In mid to late May, work will commence for the construction of the three elevators at the railroad station. Phase 1, which entails utility trenching, will commence with Atlantic Avenue being closed at Carlton Avenue for about 1 ½ weeks. Carlton Avenue will reopen and for about 2-2 ½ weeks, work will continue under the railroad. During Phase I, 36 parking spots under the railroad will be lost. Alternate parking arrangements are being finalized with 3TC.

Sometime between mid to late June, Phase II will begin. Phase II, which also involves utility trenching, should last for three weeks. No parking spots under the railroad will be affected. There will be no parking on Caroline Place and there will be no passenger drop off or pick up on Atlantic Avenue.

Phase III involves excavation and installation of the elevators. That work should start in July and is expected to last 5 to 6 months. During Phase III, 24 parking spots under the railroad will be eliminated. Again, alternate parking is being arranged. There also will be no parking on Atlantic Avenue from Arps to Dalton's Funeral Home.

Throughout this work, the station will be open and ticket machines will still be functioning.

The intersection at Tulip, Verbena, Atlantic and Plainfield/Magnolia, will be striped and signs will be installed clearly showing the intersection as a "don't block the box" area.

A right-turn lane is being installed at southbound Plainfield and Woodbine Court within the next few days, weather permitting.

We expect an answer within the next few days regarding the synchronization of the traffic lights on Tulip Avenue. The County has finally agreed and is determining the best way to do this considering traffic and the age of the signaling equipment.

Work is progressing.
