Message from the Mayor

Dear Friends,

As 2019 comes to a close and 2020 is right around the corner, our Village continues to improve and strengthen. This happens in many aspects, but most of all, it happens in the love, dedication and devotion each and every one has for our fellow residents and our community. Every individual contributes in one or more ways to make this a special place. Whether you do something as a volunteer in the Village or the schools or in an organization, you are contributing to the success of our community. If you attend an event, help at church, assist your neighbor, support a charity, or simply give a smile to someone you pass in the street you are building and strengthening this special place we all call home.

Floral Park is a special place and it is only special because everyone makes it that way. Through valiant and heroic efforts, horrific tragedies have been turned into foundations and fundraising efforts that no other community can rival. The joy of our Veterans celebrations and annual community events such as our Tree Lightings, Fairs, Block Parties and Parades bring our community closer together. When we look at our facilities, assets and services, the beauty and majesty of Floral Park shines brightly. But most of all, it is the Spirit of Floral Park that makes us what we are. The Spirit each and every person gives to our community. The pride of saying this is our community. The knowing that the hard work and effort it takes each and every family and business to call this home brings rewards to all who come here. By continuing this Spirit and working together, we can make 2020 the best year ever in our community. Together we make it happen!!!!!!

Here are some brief updates on what to expect in the coming year:

Centennial Hall

It is with great hope that by the time you read this message the Village will have closed the deal to sell Centennial Hall to the developers known as the Friedman Group. The developers have already been working very closely with our building department finalizing plans and reviewing permit requirements

so they may begin construction as soon as practically possible. This will provide new housing opportunities for many including our own residents who may be thinking of "leaving the nest" spreading out on their own or those who have decided the nest is too big for their needs and wish to downsize.

Business District Beautification Committee

Recently, the Village formed a new committee dedicated to developing options for the beautification of the Village's business districts. These districts include streets in and around Tulip Avenue, Covert Avenue and Jericho Turnpike. The committee is comprised of residents, members of the Chamber of Commerce and Village staff and officials. After the initial meetings it was decided that the focus would be the area in and around Tulip Avenue first. Many ideas and items are already being pursued to get a definitive plan to help create a desirable destination that attracts patrons and businesses to our area. We look forward to sharing those plans with everyone in the near future.

Road Programs

Road maintenance, overlays and reconstruction are daunting tasks in our Village. Our Public Works crews work tirelessly to ensure our roadways and sidewalks are maintained and safe for all of us to use.

Next year, the major planned road project includes the complete reconstruction of Floral Boulevard. The engineering and planning for this work has already begun. The same is happening for Spooner Street and the Spooner Street Parking Lot. Several other sections of road way will be done as well. Those include Marshall Ave. between Covert and Orchid. This was scheduled to be completed already, however we held off until after the 3rd Track Project portion known as the Covert Avenue Overpass in New Hyde Park was complete. Floral Boulevard is slated for complete reconstruction for its entire length. We hope to begin construction after school closes and finish before it begins in order to maintain easy and steady access to the Floral Park-Bellerose School. Other roadwork including drainage basins and small overlay areas is also planned for this coming year.

Message from the Mayor (continued)

Trees

I am happy to announce that through the yeoman's efforts of our great tree crews, the backlog of tree trimming and maintenance that existed after Super Storm Sandy is now complete. This has also led to a more routine and focused plan for trimming and maintaining the beautiful curb trees in our Village. As you are aware, the Village is very proud of its status as a "Tree City". This new program will make the work required to maintain our trees easier. I remind everyone, if you wish to have a tree planted in front of your home, please contact the Department of Public Works at 326-6320.

LIRR 3rd Track Expansion

Thankfully, the work on the Third Track Project is proceeding quickly through the Village. The work on the South Tyson underpass is done except for several "punchlist" items and other improvements to the area to be performed by Third Track Constructors (3TC) this Spring.

Work on the Plainfield Avenue Bridge, to build the "wing walls" and support for the 3rd track bridge, has begun. We are working with 3TC to minimize the traffic disruptions at this location, and we are advised that this phase of the Project should be completed by the end of February.

3TC is progressing towards completion of the three elevators at the Floral Park Train Station. We have been advised that the work on the elevators will be completed by late Spring.

The work on the retaining and sound walls is also moving forward. We expect 3TC to be out of the DPW Yard and "Pit" Ballfield by this Spring. 3TC is promising us a restored and improved "Pit" Ballfield to be ready for use this April, in time for Little League season. Also, by the end of May, 3TC should be out of the DPW Yard on North Street and that area will be improved.

Issues arise on the Third Track Project on almost a daily basis. We are grateful we have developed a good working relationship with the 3TC team so issues can be addressed promptly and this Project can move toward completion (and out of Floral Park) as soon as feasible.

Belmont

As of now, the Village's legal action in regard to the Belmont Redevelopment Project is currently going through the process within the court system. In the meantime, we have been in contact with Senator Kaplan's office and with the office of Assemblywoman Solages in the hopes of getting all related parties together to work towards plans to provide protections for our Village as this project proceeds. We will continue to update everyone as new information becomes available.

Police Department Vehicles & Technical Upgrades

"Floral Park is the 3rd Safest Place to Live in NY" (as published and recognized by several publications). I think that says it all. This doesn't happen by sheer luck. It happens because we have a dedicated, professional and very caring group of police officers and staff that work to protect each and every one of us and continually provide a safe and secure place for us to live and work and raise our families. It also requires the right tools, equipment and training to allow our staff do their job to its optimum level. This year we will be purchasing two new police vehicles, as well as updating various software and hardware applications to help provide the support the department's needs.

Parking Meters

The Village is exploring various options to modernize our aging (and many times broken) parking meters. Implementation of new meters in the kiosk at the Carlton Avenue Parking, new meters at other parking lots, uni-meters along our business districts, pay-by-phone and many other improvements are being explored. We hope to begin implementing some of these changes in early 2020.

Building Department Access Online

Under the new Building Department administration, automation of the permit process has become a priority. Having applications available online and providing a streamlined approach to applying for and receiving basic building permits will help our residents improve their homes and hopefully make construction and renovation projects easier. There will be more information available in early 2020.

4-Village Studio Renovations

During this past year, our award-winning television studio went through some beautiful renovations and modernization. This coming year new lighting and other upgrades will be made. This studio has been a wonderful volunteer experience for many of our young students who wish to enter the television and media fields. The practical, hands-on experience and freedom to create media programs give them a leg-up on their peers as they pursue careers in these and related fields of employment.

Library Young Adult Area Renovations

Renovation work began on the new young adult area in the library. The area will be located in the same section of the mezzanine and will feature a bigger meeting space and new furniture. Our young adult program has grown over the past few years and provides a wonderful alternative to our children who wish to explore their love of reading and creativity. The renovations should be completed within the first few months of 2020.

Village of Floral Park Leisure Pass or the 2019 resident pool pass is required for enrollment in these classes. As of January 1, 2020 all of the 2018/2019 leisure passes expire and will need to be renewed. Bring your old pass and a current utility bill to the Recreation/Pool Building for renewal during normal business hours, Monday-Friday 9:00am to 7:00pm. Forms for the NEW Leisure Pass and Session II Programs may be found in the lobby of the Recreation/Pool Building and in the Shelterhouse. 2020 VILLAGE SUMMER EMPLOYMENT

Applications for 2020 summer season are available at Village Hall, Recreation Center or may be downloaded from the Village's website: www.fpvillage.org.

Applicant's skills, experience & residency will be considered first—so please make sure you include this information on the application. Completed applications will be accepted any time after January 6, 2020 at Village Hall, One Floral Boulevard. Working papers (only if under the age of 18) and proof of physical are required with the application.

Lifeguard Application: The minimum age requirement for a lifeguard is 16 years of age by **January 1, 2020**. Up-to-date lifeguard certification, current CPR & first aid certifications, working papers (under the age of 18 years) and proof of a physical exam administered no earlier than June, 2019 must be presented with the application.

Park/Pool Attendant Application: The minimum age requirement is 17 years of age by **January 1, 2020**. Working papers (under the age of 18 years) and proof of a physical exam administered no earlier than June, 2019 must be presented with the application.

ASSESSMENT DEADLINE

Residents are reminded that **December 31, 2019 is the filing deadline for all village property tax exemptions. Senior Exemption Renewal Applications** were mailed out in September. At this time, there has been no increase in the "maximum income limit of \$37,400" established by New York State guidelines.

New Senior applicants can call the Assessment Department for an application.

Veterans applications and **Volunteer Firefighter** applications are available on our website as well as at Village Hall and at the Assessment Department located at 1 Pool & Garage Road. We remind the veterans that a local law passed in 2000 allows veterans who own shares in cooperative apartment complexes, to file for a partial tax exemption. We also remind and encourage any veteran having a Disability Rating or a change in his or her Disability Rating, to contact the Assessment Department. **Change requests and new applications** must be submitted by the December 31st deadline.

If you are a **new property owner** in the village or you are a property owner who has a **mailing address change, bank change, or have satisfied your mortgage**, please contact the Assessment Department as soon as possible to update our records and direct future tax bills and correspondence to the correct address or bank.
