15	MR. BELLICO: John Bellico, 84-11 159th Avenue,

17	MAYOR FITZGERALD: Good evening, Mr. Bellico.
18	MR. BELLICO: Mr. Mayor.
19	MAYOR FITZGERALD: Thank you for coming in this
20	evening. We received the documents, if you can state for
21	the record what the purpose of the establishment is and
22	give us some details, we'd appreciate it.
23	MR. BELLICO: Be my pleasure. The 292 Jericho
24	Turnpike will be corporate headquarters for a national
25	501(c)3 law enforcement military charitable organization.

1	I found Smoking Shields in 2015, on the eve of a
2	law enforcement line of duty death. Our purpose was to
3	build each other up and to come together, besides the
4	uniform and the rank, just come together as cops and help
5	each other out in times of need, that was in 2015. I
6	started with 15 people, currently we have 12 different
7	states and we have 3,000 members nationwide.
8	MAYOR FITZGERALD: Can I just stop you for one
9	second?
10	MR. BELLICO: Yes, sir.
11	MS. LANZA: It's showing that you are muted on
12	here. It just popped up. Good.
13	MAYOR FITZGERALD: Sorry. Sorry for those on
14	Zoom.
15	Proceed please. Thanks.
16	MR. BELLICO: We're here today to ask for the
17	change of permit from office space to gathering. We will
18	be using the location for our once a month general meeting
19	where all of our membership is allowed to come down and we
20	vote on how we're going to use our funds, what events that
21	we're going to either by tickets for or help support, if
22	any of the different agencies, because we do represent 45
23	different New York law enforcement agencies who has needs
24	that they need to take care of, line of duty families, sick
25	and injured kids.

1	We do a lot with military personnel, we have
2	several organizations, one of which, our main charity that
3	we donate to is called Cigars for Warriors, a taste of
4	home.
5	As we said in the beginning, cigars it started
6	off as a cigar club, and it quickly grew to a nonprofit
7	organization, we actually DBI as Smoking Shields, we
8	dropped the cigar club portion of it, but we do collect
9	cigars, lighters, accoutrement with the cigars and we ship
10	them overseas to service men and women around the World.
11	We have pictures back from guys on aircraft
12	carriers in Afghanistan just enjoying a cigar, relaxing,
13	getting a little piece of home, getting themselves out of
14	that war mentality.
15	We also donate a lot to the Nassau County SPCA.
16	Last year we ran an event for them and raised \$10,000.
17	Myself and my vice president Dan will be retired from the
18	NYPD in a few months and we're actually going to be joining
19	the SPCA as investigators for the County.
20	MAYOR FITZGERALD: I think we all probably have a
21	couple of questions.
22	MR. BELLICO: Absolutely.
23	MAYOR FITZGERALD: You mentioned that it's once a
24	month. Are you only going to be open once a month?
25	MR. BELLICO: No. Our membership we're not

1	
1	open to the public, it's only members only. We have RFID
2	locks on the door and each member is issued an ID card to
3	their name, to their membership ID, they scan in and scan
4	out whenever they want.
5	As a law enforcement officer you work crazy hours,
6	everyone has different days off, it's hard to get together,
7	hard to go to places that are open if you're working a
8	midnight tour, you need someplace to unwind, our
9	memberships can go there, there's TV's on the wall, we have
10	a dartboard, go relax, just unwind, it's a safe place they
11	can get away from the World, especially in the current
12	climate that we're in.
13	MAYOR FITZGERALD: So is it possible it would
14	potentially be open 24 hours, or accessible 24 hours?
15	MR. BELLICO: The building is accessible 24 hours,
16	yes.
17	MAYOR FITZGERALD: How many people would be the
18	most you would envision being at the establishment at one
19	time?
20	MR. BELLICO: Our monthly meetings are anywhere
21	from 25 to 50 at any one given time.
22	MAYOR FITZGERALD: And will there be any cooking
23	on premise?
24	MR. BELLICO: No, we don't have, it's not set up
25	for cooking.

1	MAYOR FITZGERALD: And you mentioned 25 to 50
2	people. Off the top of my head, maybe it's on the diagram,
3	how many spots are in the lot?
4	MR. BELLICO: Forty-nine.
5	MAYOR FITZGERALD: There's 49 parking spots?
6	MR. BELLICO: No, members 25 to 49.
7	MAYOR FITZGERALD: How many parking spots are on
8	the property?
9	MR. BELLICO: Twelve.
10	MAYOR FITZGERALD: Just to let you know that we
11	have with any community lot laws and ordinances and, you
12	know, we do have two-hour parking, and inclusive around the
13	corner from the establishment on Hitchcock there is a
14	two-hour parking limit, and there's no parking overnight.
15	MR. BELLICO: Yes, sir.
16	MAYOR FITZGERALD: Obviously late hours, parking
17	hours could be an issue.
18	MR. BELLICO: The meeting would only be an hour or
19	two at tops, if that's it, it wouldn't last more than
20	two hours. So we wouldn't go over the two hour permitted
21	parking.
22	MAYOR FITZGERALD: I will turn it over to my
23	fellow Board members. Deputy Mayor Pombonyo.
24	DEPUTY MAYOR POMBONYO: Thank you. Welcome.
25	MR. BELLICO: Thank you.

1	DEPUTY MAYOR POMBONYO: Are you all here tonight
2	in law enforcement, or have been in law enforcement?
3	MR. BELLICO: Yes.
4	DEPUTY MAYOR POMBONYO: First of all, thank you
5	for your service.
6	MR. BELLICO: Thank you.
7	DEPUTY MAYOR POMBONYO: Thank you for coming
8	tonight, and thank you for thinking of Floral Park to
9	establish this nonprofit that you are looking at. I guess
10	as expanding into our town, we are very proud of nonprofits
11	we have here.
12	MR. BELLICO: We look forward to being part of the
13	family.
14	DEPUTY MAYOR POMBONYO: That's important to us
15	too.
16	Do you ever have others coming in for other
17	reasons? Say somebody who is doing business with the
18	nonprofit who is not a law enforcement official would be
19	coming in to talk to you about an initiative of a project
20	or something like that? How often would that occur?
21	MR. BELLICO: Without one of the board members
22	present we wouldn't be letting anybody into the building.
23	Just someone from the board, or we have a house committee
24	that we set up. Someone would always be there.
25	A lot of charitable organizations, you know, we

1	meet as a collective to try and figure out how we can help
2	each other out. So I guess the answer to that would be,
3	yes, absolutely.
4	DEPUTY MAYOR POMBONYO: That's nice.

6	and running. We are putting our name to it so we can get
7	it out to more law enforcement agencies, because we do
8	represent 45 different New York State law enforcement
9	agencies, so we're partnering with them, they maintain the
10	lines, you can call up the line at any time and ask for a
11	denomination or a peer counselor of your choice and they
12	will connect you to that person. It's not a physical
13	structure, it's just more of a networking thing. We're
14	using our name, they're using their name and getting
15	together to get the knowledge out to our membership.

BELLICO: No, it's like a Masonic temple or a Knights of Columbus, just someplace for the guys to go 14 unwind. 15 16 TRUSTEE STEWART: This is kind of uncomfortable 17 for me to ask, but being that marijuana is now legal --18 MR. BELLICO: No, no. 19 TRUSTEE STEWART: -- members won't use? 20 MR. BELLICO: Absolutely not. Twenty years in the 21 NYPD, that will not happen, absolutely not. There's 22 actually a sign on the wall that says, any illegal activity 23 that we catch in here will be prosecuted to the full extent 24 of the law. 25 MAYOR FITZGERALD: Just for the record, you will

8	it's right off the Cross Island, it's pretty centrally
9	located. I live in Queens, in Howard Beach, so it's not
10	far from my house either. It was a very good location.

12	As far as trash disposal, are you using Village
13	sanitation?
14	MR. BELLICO: Yeah. I believe we had a mixup on
15	the dates when we first got into the place and we figured
16	out which date the garbage has to go out, that's part of
17	the house committee as well, they'll take the garbage out
18	to the street.
19	MAYOR FITZGERALD: On the garbage, if I could just
20	ask, make sure you don't put it out early.
21	MR. BELLICO: Yes. 6:00 p.m., right?
22	MAYOR FITZGERALD: Kev, on the commercial
23	districts.
24	MR. GINNANE: Yeah, Tuesdays and Fridays.
25	MR. BELLICO: That was my fault. I put on the

1 sign the wrong days and they were just following what I 2 told them to do. 3 MR. GINNANE: Sunset. Sunset the night before. 4 MR. BELLICO: Yes, sir. MAYOR FITZGERALD: Also what Trustee Chiara 5 6 mentioned about signage, just to let you know that if you 7 do want to put signs up outside that you need to go to Architectural Review Board, and our Superintendent Renee 8 9 Marcus will help you out if you are going to do signage. 10 MR. BELLICO: Great. 11 MAYOR FITZGERALD: Also same thing, any other 12 alterations to the building please, you know, reach out to 13 our building department before you start with anything. MR. BELLICO: Yes, sir. 14 15 MAYOR FITZGERALD: If there is no other questions, 16 if you don't mind taking a seat, I will ask the public if they have questions or comments. 17 18 MR. BELLICO: Thank you. 19 MAYOR FITZGERALD: Is there anyone here in Village 20 Hall that would like to speak for or against this proposal? 21 Sure, I see two hands, either one. 22 Good evening and welcome. If you would give your 23 name and address to the stenographer and she will swear you 24 in. 25 MS. SALVIA: Leonore Salvia, at 1 West Hitchcock

3	address your questions to us and we'll take them.

6	MS. SALVIA: I am just here because I happen to
7	live right behind the building. And I noticed presence
8	last year in August approximately, July-ish, August, and
9	for me it was odd because we were COVID, like heavy duty
10	coming out, starting to whatever, and I heard a tremendous
11	amount of noise outside. I just walked out my back door
12	and there it is, tremendous amount of cigar smoke, yelling,
13	screaming, whatever.
14	But I do want to preface one thing, I should have
15	started out this way. You know, I have a tremendous amount
16	of respect for the blue and the military, I am a patriot, I
17	am an American citizen and happy to be a part of this
18	Country, and if it wasn't for them we wouldn't even be
19	standing here, so I am grateful to have them, and I
20	appreciate and honor everything that they do and all of the
21	organizations that they have and all the help. If
22	anything, I would be happy to help them in that way and
23	helping assist the officers with Post Traumatic Stress
24	Disorder, especially with what's going on, I am really
25	sympathetic to that, like, tremendously.

1	However, when you live there behind something like
2	that, that's a whole other ball game. I didn't complain
3	when I first saw it happen because I didn't want to be too
4	much of a pain in the neck, but now that you are knowing
5	that you are going to be there all the time, $24/7$ , and with
6	very little parking and one time a month meetings, but it's
7	open 24/7, and all the cigar smoke and how it affects the
8	environment, I believe that it does affect the environment,
9	and neighbors also have said the same thing. In fact they
10	were quite frightened because they didn't know who these
11	people were, and now that we know they are police officers
12	we're probably more safer than I thought, but I didn't know
13	at the time, now I know. I feel safe, safer than anybody
14	really because I am right behind there. I could imagine if
15	they are off duty and somebody tries to do something, well,
16	I would hope that they would react and protect us as they
17	always do.
18	The only concern I have, like I said, is that
19	cigar smoke and the noise, the loudness. It was weekends,
20	you know, but still all in all we are right here next to
21	Jericho and all, so I'm really concerned about living like
22	that now all of a sudden.
23	MAYOR FITZGERALD: I'll ask them to come up and
24	address that.

16	I know that he said smoke inside indoor, not going to be
17	24/7, but I like to have Floral Park to be peaceful, no
18	such a thing like I want to have like air I I don't want
19	to have any air pollution basically. It might happen, it
20	may not happen, I don't know, nobody knows, no one knows.
21	So I would like to have a clean environment.
22	Past summer my front yard caught fire because
23	someone throw cigarette on the grass, before COVID no
24	yeah, COVID last year, before that, few years 2019 in
25	summertime around August my front yard caught fire because

1	someone, pedestrian throw cigarette on my front yard on
2	Plainfield, I'm on Plainfield Avenue. My kid go to school,
3	nobody is home. So lucky I have two people walking along
4	that area saw that cigarette make smoke, you know, so the
5	person call 911, the fire department came to help. So I
6	when I got home that evening I said, what's going on on my
7	front door, all the black thing on my grass. So I went to
8	police department right here, police station, they told me
9	that somebody, good person call 911, that's why the fire
10	department came to help. So I'm thinking if this happen to
11	me, I don't want to happen, it's a cigarette, I scared. I
12	only have one house in Floral Park, I have kids at home, I
13	want to be safe. So that's why I am here today.
14	MAYOR FITZGERALD: Okay, thank you. I will ask
15	the applicant to address your concerns.
16	Is there anyone else in Village Hall that wants to
17	speak? Okay, sir.
18	If you would give your name and address to the
19	stenographer.
20	MR. DICARLO: Jason DiCarlo, 136 Tulip Avenue,
21	Floral Park.
22	(Whereupon, Jason DiCarlo was so duly sworn. )
23	MAYOR FITZGERALD: Welcome.
24	MR. DICARLO: Sure. I just maybe a few things.
25	My brother was in the attack in the intelligence agency in

6	MAYOR FITZGERALD: That's fine. Take your time.
7	MR. DICARLO: I just found out an hour ago. I
8	understand, you know, cigar bars, it's fine, but they
9	legalize pot, they can have pot now; it's a little pain in
10	the ass going around, you know, curbing that. And what is
11	it two, three years you can sell it in a bar or sell it
12	because you have a cigar bar. Where does it go from there?
13	Got to be a stop somewhere. How do you put it to a halt?
14	It's the first town in Nassau County once you get
15	out of Queens, then goes to New Hyde Park, Garden City, I
16	just don't know why we have to be the first one to say yes
17	to this, you know.
18	So that's all I have to say.
19	MAYOR FITZGERALD: I think the applicant was
20	pretty clear that they would not be selling Cannibis on
21	premise. And just for your information, June 1st we are
22	having a public hearing on allowing or disallowing Cannibis
23	to be sold within Floral Park's boundaries, so come back in
24	two weeks.
25	MR. DICARLO: Thank you.

1	MAYOR FITZGERALD: Thank you. Good to see you.
2	Is there anyone else in Village Hall that wants to
3	speak? Is there anyone on Zoom that would like to speak?
4	If you can let me know and raise your hand.
5	MS. SALVIA: There was one comment, may I make it?
6	MAYOR FITZGERALD: Give me one second.
7	You want to approach?
8	MS. SALVIA: I forgot to mention it. This is the
9	most important thing, at least for me and for her and a few
10	other people. There is some neighbors that just didn't get
11	a chance to come tonight, I don't know why.
12	This smoking outside thing, you know, they need a
13	place to do what they have to do but with closed doors and
14	inside, whether they're drinking or smoking, go ahead,
15	enjoy yourself, but the cigar smoking outside and the
16	drinking, that's really what my thing is just because I'm
17	literally right behind there, right behind there, so I just
18	open my door and there it is. It's even encroaching into
19	my privacy as a citizen and as a taxpayer in this town. So
20	I'm hoping that you will also consider that, that was one
21	comment I left out, the smoking outside.
22	MAYOR FITZGERALD: Thank you. Would you like to
23	come up?
24	I think there was two kind of themes there, one
25	about smoking outside, we didn't ask you if the smoking

1 would be inside or outside, or applying for a liquor 2 license. 3 MR. BELLICO: One hundred percent no liquor license, we will not sell any liquor there, no. 4 As far as I know smoking outside there's no 5 ordinance about that, is there? 6 7 MAYOR FITZGERALD: There is --MR. BELLICO: We'll put up signs outside, be 8 9 respectful of our neighbors. I don't know how to stop them 10 from smoking outside if it's not illegal to do. I will 11 make sure that my membership knows to be as quiet as possible, be respectful of our neighbors, absolutely, we 12 13 don't want to offend or upset anyone in the neighborhood. 14 MAYOR FITZGERALD: Would most of the smoking be outside or inside? 15 16 MR. BELLICO: Mostly outside. If they smoke 17 inside, I'm not there, I don't know what they do. 18 MAYOR FITZGERALD: Okay. Anyone on the Board have 19 further questions, comments? 20 (Whereupon, there was no response.) 21 MAYOR FITZGERALD: So we'll think about this and 22 we will get back to you. 23 MR. BELLICO: Thank you very much. 24 MAYOR FITZGERALD: We'll read the transcripts. 25 I would like to ask for a motion to close the

15	MS. WALSH: And Mayor Fitzgerald?
16	MAYOR FITZGERALD: Aye.
17	Thank you for coming. Thank you for your time.
18	(Whereupon, the Public Hearing was concluded and
19	stood adjourned.)
