NOTICE OF ADOPTION OF THE INCORPORATED VILLAGE OF FLORAL PARK LOCAL LAW NO.6 OF 2021 ENTITLED "Local Law 6 of 2021 adopts Section 73-10 of the Code of the Incorporated Village of Floral Park so as to eliminate the annual filing requirement for renewal of Senior Citizen Tax Exemptions for senior citizens who have received the exemption on five consecutive assessment rolls."

PLEASE TAKE NOTICE that pursuant to Article 9 of the New York State Constitution, the provisions of the Code of the Incorporated Village of Floral Park ("Village") and the Municipal Home Rule Law of the State of New York, as amended, a public hearing was duly called and held on October 19, 2021 by the Village Board of the Incorporated Village of Floral Park on the proposed adoption of the Incorporated Village of Floral Park Local Law No. 6 of 2021 and following the close of the hearing, the Village Board duly adopted the Incorporated Village of Floral Park Local Law No. 6 of 2021 entitled: "Local Law 6 of 2021 adopts Section 73-10 of the Code of the Incorporated Village of Floral Park so as to eliminate the annual filing requirement for renewal of Senior Citizen Tax Exemptions for senior citizens who have received the exemption on five consecutive assessment rolls."

Section 1. Legislative Intent

This Local Law adopts Section 73-10 of the Code of the Incorporated Village of Floral Park so as to eliminate the annual filing requirement for renewal of Senior Citizen Tax Exemptions for senior citizens who have received the exemption on five consecutive assessment rolls. Under the new law, such seniors need only file an Affidavit of Continued Eligibility rather than a full application with all the supporting paper work, including copies of tax returns.

§ 73-10

AFFIDAVIT OF ELIGIBILITY FOR SENIORS WHO RECEIVED EXEMPTION FOR FIVE CONSECUTIVE YEARS

Notwithstanding anything in this Chapter to the contrary, Senior Citizens who have qualified for the Senior Citizen Tax Exemption for the last five (5) consecutive years need not file an application annually. Rather, a senior citizen who has so qualified may

file an affidavit in the form perscribed by the New York State Department of Taxation and Finance.

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 6. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.




