Section 1. Legislative Intent	
This Local Law rescinds the adoption of Local Law No. 1 of 2021 because it was premature filed with the Secretary of State prior to the expiration of the period to file a permiss referendum.	
It is the intent of this local law to opt the incorporated Village of Floral Park out of hosting retail cannabis dispensaries and/or on-site cannabis consumption establishments within its boundaries.	
Section 2. Authority	
This local law is adopted pursuant to Cannabis Law §131, which expressly authorizes cities and villages to opt-out of allowing retail cannabis dispensaries and/or on-site cannabis consumption establishments to locate and operate within their boundaries.	
Section 3. Local Cannabis Retail Dispensary and/or On-Site Consumption Opt-Out	
This Board of Trustees of the Incorporated Village of Floral Park, County of Nassau, hereby opts-out of licensing and establishing retail cannabis dispensaries and/or on-site cannabis consumption establishments within its boundaries.

Section 4. Severability

Pursuant to Cannabis Law §131, this local law is subject to a permissive referendum and thus may not be filed with the Secretary of State until the applicable time period has elapsed to file a petition or a referendum has been conducted approving this local law.
