ANNUAL BUDGET HEARING APRIL 13, 2022 8:00 PM VILLAGE HALL

Dear Resident,

The Village Board will be presenting the proposed Village Budget on Wednesday, April 13, 2022, at 8:005 p.m. in Village Hall, 2nd floor Court Room.

The Village of Floral Park is a full-service Village providing many of the services you need every day. These services include, but are not limited to, Police, Fire, Roads, Parks, Library, Garbage and Recycling, Street Lights, Shade Trees, Sidewalks, Parking Lots, Buildings, Village Justice Court, Village Hall Services, Pool Complex, Arts & Culture, among others. We recognize that for many homeowners the Village of Floral Park's portion represents approximately 1/3 of your total property tax bill. We are committed and continue to seek to provide Village services in the most economical manner possible. Within this newsletter, you will find a page dedicated to the allocation of Village taxes. This will provide you the opportunity to see a breakdown of your taxes as they relate to the areas of service the Village provides its residents.

Most of these services are provided to you with revenues derived from Village portion of the real estate taxes you pay on your home or building. That being said, the rest of your real estate taxes are used to support other local governments and our great school districts. The reason we point this out is to show you how much you do actually get for your tax dollar. We all strive for the best when it comes to our home or place of business and, when you look at our wonderful and beautiful community, please remember this is your home or your place of business as well.

The Village Board and staff are custodians of the taxpayers' trust to spend tax dollars in the most efficient way. In preparing the draft budget we treat every dollar as if it was our own. As you would do, we work to ensure the "Best" possible use of it at the most economical value possible.

To that end, the proposed tax-levy increase for 2022-2023 is within the New York State Property Tax Cap. The allowable New York State Tax Cap for a tax levy increase for Floral Park for 2022-2023 fiscal year is 2.55%. The proposed tax levy increase in this Tentative Budget is 2.53%. The New York State "Tax Cap" applies to the "tax levy". The "tax levy" refers to the overall amount of taxes the Village must raise to pay its projected expenses.

The "tax rate" refers to the amount you actually pay on your tax bill based on the assessed value of your property. The tax rate increase for 2022-2023 is actually lower than the tax levy increase for the coming year because the total assessed value of all taxable property within the Village (both commercial and residential) grew during the last year due, in large part, to increased new construction and building improvements within the Village. Because the total assessed value of all taxable properties increased, the tax rate increase of 2.26% is below the tax levy increase.

The budget proposes a tax rate of \$14.2542 per one hundred dollars of assessed valuation, compared to the \$13.9391 tax rate established for the 2021-2022 fiscal year. Based on the budget as presented, a typical homeowner in the Village of Floral Park owning the average home with an assessed value of \$37,145 will pay an additional \$117.05 for the 2022-2023 fiscal year for Village government services. The total annual Village tax for a home assessed at \$37,145 would be \$5,294.72.

Many of the costs associated with providing the Village services continue to rise. One cost in particular that continues to rise is health care costs for our employees who provide these services. Health care costs have risen dramatically over the last several years. After a few years of increases, health insurance costs levelled off for a year or two. However, health insurance costs appear to be rising again and the predictions for next fiscal year is that these costs will rise over 9%. Also, other insurance costs, such as property insurance, general liability, cyber security and workers compensation insurance are projected to increase by approximately 10%. Additionally, New York State increased the amount for Medicare reimbursement for which the Village is responsible by over 20%.

Mayor's Message Continued:

Despite these financial challenges, the Village will continue to make investments to maintain and improve our village services. We will continue with our road program with the reconstruction of Marshall Avenue, Clayton Avenue, Spooner Street, the Spooner Parking Lot and Hinsdale Avenue between Jericho Turnpike and Lowell Avenue. We also plan to increase the number of overlay projects to improve the surface on other roads. The Village Board also recently approved the retainer of an architect to plan the renovation of the "multipurpose court" (roller hockey rink) at the Recreation Center. Further, the Village is working with our Fire Department to replace one of our older pieces of equipment, the Spartan/Saulsbury Pumper truck. All of these projects are necessary to maintain the level of services our residents enjoy.

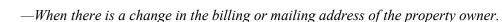
