 Current Survey showing all property improvements. (if survey is older than 12 months, a Survey Affidavit is required) Show proposed fence locations on the survey indicating height and type of fence. Fencing for residential properties may only be 4' high, except across the rear property line where 5' is permissible. On an inside lot, fencing may not extend beyond the front foundation line of the dwelling. On corner lots, no fence shall be allowed in a side yard that abuts a street. On corner lots, no rear yard fence shall extend nearer the street than 1/2 of the side yard setback for the property, but in no event closer than six feet to the property line. That portion of a rear lot line fence on a corner lot located within the side yard setback shall not exceed four feet in height. For reference, the shortest side of the lot is considered the front of the property regardless of the location of the front door. See attached sheet for types of fencing that are acceptable and approved by the Architectural Review Board. In the event you wish to install a different type a photo or drawing of the prosed fence shall be include in your application and may be subject to Architectural Review Board approval. The finished side of the fence must face outward and fencing must be located entirely within the property lines. Commercial properties and residential properties that abut commercial properties are allowed solid fences up to 6' in height with some restrictions as outlined in zoning code. You must call before you dig - dial 811 a minimum of 48 hours before beginning any digging project




CIRCLE STYLE OF FENCE PROPOSED


The following generic designs have been pre-approved by the Architectural Review Board by resolution at the June 2006 meeting. Open designs of wood vinyl or wrought iron material are permitted, provided the distance of the opening in the slats is 3/4 of an inch or greater. The permitted colors are limited to white, beige, grey or wood tones. Wrought iron or aluminum fences can be black. Any styles or colors that differ from the pre-approved designs must be presented to the ARB for approval.

Solid and chain link fences are <u>prohibited</u> on residential properties. Solid fences may be installed on residential properties that abut a commercial property.




Old English Lattice







Scalloped Picket




Estate Fence




Framed Ovation Style




Ornamental Picket



Square Lattice




Semi-Privacy Diagonal Lattice
