Village Code Requirements Summary: see Village Code section 81 for full regulations				
 the contractor shall follow the Village specifications as outlined in Chapter 81 of the Village Code. The width of all sidewalks shall be a minimum of 4'-0" (unless otherwise approved by the Superintendent of Public Works) and shall be a minimum of 4" thick, except where such sidewalks are crossed by driveways; the sidewalks shall be a minimum of 6" thick through the width of such driveway. All aprons shall be a minimum of 6" thick and poured separate from the curb. Curb construction shall be constructed with a minimum width of 6" across at the top, 8" at the base. The height of the curb shall be 6" above grade and shall be a minimum depth of 12" below grade. The contractor must call before you dig - dial 811 a minimum of 48 hours before beginning any digging project. Village tree and root systems must not be disturbed. Once all work is formed, the contractor must schedule an inspection with the Village a minimum of 24-hour notice. An inspection to verify the size, depth, and reinforcement is required before any pour. All concrete work must be approved by the Village.
