1 MAYOR FITZGERALD: Good evening. I ask
2 everyone to stand for the Pledge of Allegiance.

3 (Pledge of Allegiance said.)

4 MAYOR FITZGERALD: Good evening and
5 welcome to the Village Hall, people on Zoom,
6 welcome, to the public hearing for the
7 2023/2024 budget. Before we get to going over
8 the budget, we first need to adopt, talk about
9 adopting a Local Law.

10 I would ask our Village Administrator,
11 Jerry Bambrick, to read the notice.

12 MR. BAMBRICK: Legal Notice. Notice of
13 Public Hearing Incorporated Village of Floral
14 Park proposed Local Law Number 1 of 2023.

15 Please Take Notice that pursuant to
16 Article 9 of the New York State Constitution,
17 the provisions of the Code of the Village of
18 Floral park and the Municipal Home Rule Law of
19 the State of New York, a public hearing will
20 held in Village Hall Courtroom of the
21 Incorporated Village of Floral Park, One Floral
22 Boulevard, Floral Park, New York on the 12th
23 day of April, 2023 at 8:00 p.m. (immediately
24 before the Budget Public Hearing) to consider
25 the enactment of a Local Law entitled: "A
