A Best Day in Floral Park

On Monday, May 29th, Memorial Day, our American Legion joined with the Village of Floral Park, our Police, Fire and Public Works Departments, the Floral Park Memorial High School and John Lewis Childs School Bands, many community organizations, our houses of worship, residents and businesses to honor those who have served our country and are no longer with us, and our brave Purple Heart recipients. Our heartfelt gratitude goes to all who marched with us throughout our Village, those who cheered so enthusiastically for our parade participants, and those who shared in the pride at our ceremony. Thank you all!

Police Department

Our Police Department is well known for its partnerships with the four schools in Floral Park. Perhaps one of the reasons for the great success of these partnerships is the Department's School Resource Officer or SRO position, now held by Officer Murphy and previously held by Sergeant Viscusi and retired Officer John Groshans. This vital role, established in 2010 in collaboration with our school leaders, encompasses important instruction on topics such as internet safety, bike safety, stranger danger, Halloween safety, prom safety, and many others that protect our students. The SRO role also encompasses support for students, faculty and parents. Our SROs are trained and certified by the National Association of School Resource Officers (NASRO) and work under the direction of Lieutenant Doherty, also SRO certified.

In addition, other important components of our Police Department/School partnerships include recess evacuation drills with the lunchtime monitors and students; Stop the Bleed kits located in the schools, accompanied by valuable staff training; police portable radios for school office staff use in emergencies; and reunification toolkit boxes to expedite reuniting our children and their families, saving precious time in a crisis.

Floral Park-Bellerose School District Interim Superintendent Lisa Ruiz has stated, "The partnership we have with the School Resource Officers, as well as the entire Department, is invaluable and we deeply appreciate all of the support, knowledge, time and resources you provide for us." Thank you for your kind words, Superintendent Ruiz.

Meanwhile, another significant function of our Police Department is performed by the Motor Carrier Detail, a NYS certified group of officers including Sergeant Naughton, Officer Kratochvil and Detective Timm who, with additional officers, carry out comprehensive commercial motor vehicle inspections of the trucks that travel on our Village streets, often focusing on Plainfield Avenue. In April, eleven inspections resulted in 51 moving/equipment violations and both trucks and drivers being taken out of service. The recent May inspections of twelve vehicles on Plainfield Avenue resulted in 60 moving/equipment violations with five vehicles taken out of service and two towed.

As our Police Department staffing increased today with the graduation of three of our new officers from the Nassau County Police Academy, it is expected that our Motor Carrier Detail will have greater capacity to increase our commercial motor vehicle inspections.

Thanks to our Motor Carrier Detail for their important work, and congratulations to Floral Park Police Officers, Class of 2023, Rocco Sollecito, Thomas Monahan and James Incantalupo. Welcome and be safe out there!

Building Department

Several updates: Demolition is nearly complete on the Covert Avenue fire property and foundation work is expected to start early summer. Centennial Hall is with the County waiting on the site plan approval. The developer is submitting paperwork for the demolition of the existing building which is expected to be done over the summer. The New Multi-Purpose Rink at the park was recently completed with the application of the playing surface. Unfortunately, the playing surface is showing areas where it did not adhere properly. We have been in contact with the manufacturer's representative and they are investigating methods to fix it. Thank you to Building Superintendent Renee Marcus and her staff for all their hard work on the various ongoing projects.

A reminder to residents that all permanently installed air conditioning and heat pump units require a permit and have zoning requirements regarding the placement of the outdoor units. Permits must be filed prior to installing these units. Please call the Building Department for assistance or information regarding the allowable placement areas. For all existing residents who have pools, there are proposed changes to eliminate the requirement for the annual pool permit. Notices from the Building Department will be sent to all existing pool owners this week. The permit requirement has not changed for any resident considering installing a new pool.

Pool and Recreation

This past Saturday at 12pm, I along with the Mayor and my fellow board members had the pleasure of greeting residents and celebrating the official opening of the pool for the season. A lot of work goes on to get the pool ready and open. Thank you to Recreation Superintendent Kurt Meyfohr, Pool Director Thomas Dillon and the staff for all their hard work to open this season. Unfortunately, it is not without some repair issues. The kiddie pool and slides are temporarily closed while repairs are being done. They are expected to reopen shortly. We look forward to another great season of theme night parties, Family Fun Pizza Fridays, swim team tournaments and enjoying time with fellow residents.

In the Park, Field 6 was completed and opened last week. Little League is in full swing enjoying games nightly and the summer programs are set to start Monday, June 26th. It is a great time of year at the recreation center with baseball, basketball, tennis, volleyball, pickle ball and much more. Come down and enjoy the fun; we look forward to seeing everyone this summer.
