# Beverly Avenue, Marshall Avenue, Cunningham Avenue, Clayton Avenue Current

There are twelve spots adjoining Covert Avenue disbursed along the side streets (Meter # CV10, CV22, CV31, CV43, CV41 to CV44, CV45 to CV46). Relocated

These twelve spots will be relocated to the twelve most southern metered spots on Covert Avenue (closest to Tulip Avenue) along Key Food (Meter # CV49-CV60).

- 8. Resolution No. 2024 Authorize the settlement of the tax certiorari proceeding pending in the Supreme Court of Nassau County against the Village of Floral Park with respect to real property located at 65 South Tyson Ave, Floral Park identified as Section 32, Block 75, Lot 48 for tax years 2012/13 through 2024/25 for a lump sum of \$30,000.00 and a reduction in the 2025/26 assessment to \$80,000.00.
- 9. **Resolution 2024** Approve Roadwork Ahead to perform concrete work by removing and replacing concrete handicap ramps with detectable warning surfaces, milling and paving of Cisney Avenue between Covert Avenue and Gilbert Court, including the side streets of Orchid Court, Kenneth Court and Gilbert Court in the amount of \$216,102.00, which contract is piggybacked off the Village of Farmingdale Contract and authorize Mayor or Village Administrator to sign said contract.
- 10. **Resolution 2024** Approve Roadwork Ahead to perform concrete work by removing and replacing concrete handicap ramps with detectable warning surfaces, milling and paving of Primrose Avenue, Daisy Avenue, Gladiolus Avenue, Pansy Avenue and Mayfair Avenue, such roads being impacted by the Mandatory National Grid Gas Line Replacement Project, in the amount of \$627,547.62, which contract is piggybacked off the Village of Farmingdale Contract and authorize Mayor or Village Administrator to sign said contract.
- 11. **Resolution 2024** Approve Roadwork Ahead to perform milling and paving of Iris Avenue, Violet Avenue and Verbena Avenue between Tulip Avenue and Carnation Avenue, in the amount of \$230,525, which contract is piggybacked off the Village of Farmingdale Contract and authorize Mayor or Village Administrator to sign said contract.
- 12. **Resolution 2024** Approve Roadwork Ahead to repave and install drainage structures in the municipal parking field on Holland Avenue and milling and paving of the Library Parking lot in the amount of \$129,032, which contract is piggybacked off the Village of Farmingdale Contract and authorize Mayor or Village Administrator to sign said contract.

- 19. **Resolution No. 2024** Authorize an Agreement between the Village and the Metropolitan Transportation Authority and the Long Island Rail Road (the "MTA/LIRR") ("Settlement Agreement") resolving certain outstanding obligations under the Memorandum of Understanding between the Village and the MTA/LIRR, dated July 11, 2017 regarding the Third Track Project (the "MOU"), which Settlement Agreement includes a Main Street Restoration License Agreement ("Main Street Restoration License Agreement") which authorizes the Village to undertake certain restoration work along the MTA/LIRR property adjacent to Main Street in the Village and authorizes the Village to pay for such restoration work from additional funds to be made available under the Community Benefit Fund provided by the MOU, and authorize the Mayor or Village Administrator to sign said Settlement Agreement and Main Street Restoration License Agreement.
