Trustee Stewart offered **Resolution No. 2024-160** to oppose the MTA Queens Bus Network Redesign proposed Final Plan as presented below:

WHEREAS, the Incorporated Village of Floral Park is an incorporated municipality with approximately 16,000 residents located in western Nassau County; and

WHEREAS, the Village of Floral Park has an area of less than two square miles and is completely bisected by the right of way of the Metropolitan Transit Authority ("MTA") and its wholly owned subsidiary, the Long Island Rail Road ("LIRR"), the nation's largest and busiest commuter railroad; and

WHEREAS, the Village is also serviced by Nassau Inter-County Express ("NICE") bus service and its N24 bus, which also runs along Jericho Turnpike/Jamaica Avenue to the Jamaica Station; and

WHEREAS, the MTA, in its Queens Bus Network Redesign Proposed Final Plan (the "PFP"), has proposed a new Q110 bus route which runs directly parallel to the LIRR Mainline (which includes stops at Jamaica, Hollis, Queens Village, Elmont/UBS Arena, Bellerose and Floral Park) from the Jamaica LIRR Station (the start) to the Floral Park LIRR train station (the finish); and

WHEREAS, the new Q110, together with LIRR Mainline Service and the NICE N24 bus, would add a 3rd mode of public transportation serving exactly the same area therefore adding multiple redundancies with no increased service area; and

WHEREAS, as the proposed new Q110 route would traverse roads owned and operated by the Incorporated Village of Floral Park, the MTA would need approval to run passenger bus service over Village roads from <u>both</u> the Commissioner of the New York State Department of Transpiration, under New York State Transportation Law, Section 153(5), and from the Village under the Village Code, and at the time of this resolution neither process has been initiated; and

WHEREAS, the proposed route of the Q110 as reflected in the PFP would exacerbate existing traffic congestion and impede the delivery of essential services of the Village's Police, Fire and Ambulance first responders; and

WHEREAS, the Village has been apprised by the MTA of a potential alternate route which is not reflected in the PFP but which is under consideration by the MTA and by which the Q110 would travel northbound on South Tyson Avenue to return to Jericho Turnpike (the "South Tyson Alternate Route"); and

WHEREAS, the South Tyson Alternate Route, would not only create similar traffic problems but would also create an unacceptably dangerous condition for the Village's school children as the John Lewis Childs Elementary School (pre-K to 6th Grade) is located along this proposed alternate route; and

WHEREAS, the proposed establishment of a bus terminal for the new Q110 at the Floral Park LIRR station on a street (i.e. Caroline Place) which is narrow with minimal, if any, passing room for cars will create significant traffic backups at the station and block crosswalks and impede existing handicap access to the station

NOW BE IT RESOLVED, that the Floral Park Village Board of Trustees, here assembled, unanimously opposes the MTA's suggested termination of the Q110 Bus at the Floral Park LIRR station. We firmly believe that this it will create negative impacts on the Floral Park community, as described above, with no benefit to the residents or businesses of Floral Park or its surrounding communities. The expense connected with completing this project far exceeds any justification of need. In addition, there has been little consideration given to the severity of the adverse impacts to be suffered by our community, economically, socially and physically.

AND BE IT FURTHER RESOLVED, that we urge our constituents, their families, friends and neighbors to submit comments to the MTA to publicly state their strong and unbending opposition to the placement of the Q110 at the Floral Park LIRR station and suggest that the funds earmarked for this project instead be used for other improvements within the Queens bus network.

Fire Department

Congratulations to our Village of Floral Park Volunteer Fire Department for finishing as the Best Fire House Runner-up in the Blank Slate Media's Best of Nassau County 2024 Contest. Our Volunteer Firefighters take pride in their fire house(s) and this is a well-deserved recognition!

Our Fire Department answered 108 calls for service in the month of June. The fire companies responded to 24 calls, 84 total ambulance calls were answered, with NYU Langone responding to 74 calls and Rescue Company responding to 10 calls.

Our Fire Department continually trains, even during the summer months to ensure their readiness when an emergency arises. They are aways looking for new members, so if you are considering or have an interest in joining, stop by one of our three fire houses to have your questions answered and learn more about our Fire Department.

As mentioned at the previous meeting, the Federal Occupational Safety and Health Administration (OSHA) has proposed changes to the Fire Brigade Standards (190.156) that will have a severe impact on many Volunteer Fire Departments. Some of the proposed changes will place a financial burden on small departments and will affect volunteer retention.

Local Departments are requesting an extension to the public information process, allowing them the opportunity to have a balanced approach into consideration of the reality of each department. The comment period is coming to a close on 7/21/2024.

The Firefighter Association of New York State (<u>WWW.FASNY.com</u>) is requesting additional time to digest and appropriately respond to the proposed changes.

The Floral Park Fire Department is asking residents to send their comments to request an extension for more time for the fire services to review the changes. DPW

I would like to start this evening with an update regarding the WAWNC Water Main Installation Project:

We were informed that the water main replacement project by the Water Authority of Western Nassau County (WAWNC) on those blocks bounded by Raff Avenue, Floral Parkway and Tulip Avenue is moving along on schedule. I want to clarify for the residents that on those streets impacted by this project there will be phases to the installation. That is, if the WAWNC has trenched your street to install the new water main and then moved on to trench the next street and install the water main there, they will return to your street a few weeks later to do the residential connections of the water service. Unfortunately, the WAWNC cannot do both phases of the project at the same time because the water main installation work must be tested and the results sent to the Nassau County Department of Health (NCDOH) for their review and approval. That review by the NCDOH usually takes a few days. Once the WAWNC receives the NCDOH approval of the water main installation, then the WAWNC and their contractor will return to do the domestic water service connections to the residences. This connection to the residences involves digging up a portion of the lawns in front of the home up to the home's property line. The Village is assured that there will be full restoration by the WAWNC of any excavated portions of lawns. Also, as previously reported, once the project is completed, the Village will undertake a curb-to-curb repaving of the streets impacted by this work.

This past month, DPW has continued to sweep all Village roads as scheduled, repaired pot holes, and addressed the issues on Village roads. Building Department

With several projects taking place in our Village here are some status updates:

- A permit for medical offices was recently approved for the second floor of 170 Tulip Avenue, which is the vacant building on Tulip and Plainfield Avenues. Work is expected to start soon.
- The Tulip Avenue Walkway next to the Post Office is awaiting delivery of the fencing material. The project is expected to be completed sometime in August.
- Construction continues at One Carnation Avenue and 266 Jericho Turnpike; both projects are expected to take a year to complete from the start date.
- The plans for the restaurant at 99 Covert Avenue are currently in the code compliance review process.
- The Covert Avenue fire property project is currently with the Bank and IDA for final funding process. The hope is that it will close on the funding before the end of the month.

As a reminder, all construction work that involves moving walls, windows or doors requires a permit prior to starting the project to ensure compliance with the building codes. Please check the Building Department website for a full list of requirements and permit applications. There are currently over 35 applications available online. You are welcome to call the Building Department to ask questions or obtain assistance for permitting. For business, sidewalk signs of any kind are not permitted. No part of the sidewalk is allowed to be obstructed. Signs are a safety hazard and our sidewalks are not wide enough to accommodate them.

Recreation and Pool

We are in the middle of our third heat wave this summer making our pool a popular place to be. We have already had 8 days of extended hours this year and we have not even started the dog days of summer yet.

Wednesday, July 17th is rollback night with reduced prices on hamburgers, hot dogs and more at D&J refreshments. Our next resident's day is July 28th and next grandparent's day is August 4th. Both are great well attended days.

The swim team had its first swim meet last night against Mineola. Upcoming dates include Monday, July 22nd with Stewart Manor, Thursday, July 25th with Mineola and Monday, July 29th with Williston Park.

Congratulations to our Little League District 29 teams in 10U, Junior Baseball and 12U softball. Each team advanced to the championship game in their respective division. While they fell short, it is a great accomplishment making it to the final game. Congratulations to the players and thank you to the coaches and the league for making it happen.

Openings are still available for various summer programs and youth activities. These are listed in the 2024 Pool Book online at the Village website. Please contact the pool building for information and registration. Village of Floral Park Leisure passes are required to use the recreation complex and to register for the programs.

As a quick reminder for everyone, for safety reasons no bikes are permitted in the park.

Town-Village Aircraft Safety & Noise Abatement Committee (TVASNAC)

A press conference was held in Floral Park on July 3rd with elected officials from Town of Hempstead, Town of North Hempstead, NY State and Federal Offices to announce the filing of a petition requesting the FAA perform a study and present alternative air routes. The air traffic as we all know has increased considerably and we have low flying planes over our homes on average every 90 seconds, creating a deafening noise and hazardous air pollution. TVASNAC has been requesting this and other information for several years with little to no response. TVASNAC has also asked for the raw noise data from the Port Authority through a FOIL request which would show the actual noise levels and issues. They have not received any information to date. The goal is to demand corrective actions by creating alternate routes and make it bearable for all the residents. If they receive no response to the petition in 90 days, their plan is to file a lawsuit against the FAA.

The next meeting will be at 7:00 PM on Monday July 22, 2024 at Town Hall, One Washington Street in Hempstead. If you want to make a noise complaint regarding air traffic, you can call 1-800-225-1071. Village Emergency Management

Hurricane season is upon us and it is predicted to be an above-average season with 17-25 named storms expected. We have already seen a Category 3 hit the Texas coast. The National Hurricane Center advises everyone to "Be Prepared - Get A Plan!". Thankfully our full-service Village has a Public Works Department that maintains our trees and hundreds of drains and catch basins to limit the damage. We have the best trained Police and Fire Departments ready to respond to any emergency. However, it does not stop there. It is important for each resident to prepare in advance for heavy storms, wind and rain damage and the possibility of periods without electric. It is recommended to have supplies for at least three days and to prepare for special medical situations, if needed. Local emergency numbers include 911 and 516-326-6400. It is never too soon to get ready and be prepared.

To follow up on Trustee Stewart's report in regard to the Queens Bus redesign, there is not a lot of information provided on the website. We have studied what is available as we do with any major project that impacts the Village. I think the resolution that we passed tonight does lay out in detail some of the concerns that we have not only here in Floral Park but the whole concept of the Q110, which is duplicative of other routes that occur in Queens. Three busses and a train line running on the same route does not seem to make a lot of sense.

Board reports are quite extensive this evening, due to fewer summer meetings being held.
