### *Message from Mayor Kevin M. Fitzgerald*

Dear Friends,

As we come upon yet the end of another year, I would like to recap some of the highlights and achievements that our Village accomplished during the year. These items have allowed our Village to not only remain a great place to live, work and raise a family today but they also ensure that future generations will be able to keep that commitment alive. It is important to acknowledge that all of these items are the efforts of teams that work collaboratively to ensure the projects have a successful completion. Our entire Village community has benefited from the hard work and dedication of all our Village employees as well hundreds of volunteers that serve on committees or an active role in our Fire Department. Additionally, it is clear that having a full-service Village with a responsive and dedicated Board makes Floral Park a thriving community.

A few of the items that are of particular interest in highlighting are:

#### **Third Track**

- During the year the Village continued to work with the LIRR to complete a number of unfinished projects related to the Third Track project and close out the Memorandum of Understanding (“MOU”) that was agreed to when the project began. Some of these projects were the paving of Stewart Street and Terrace Avenue as well as the installation of new handicap curb cuts, the re-fencing and landscaping of area on Main Street and the landscaping of areas along the Hempstead Line in the Spring. Additionally, the MTA has included what they call a “renewal” of both the Floral Park and Bellerose stations in their proposed 2025-2029 Capital Plan. I would like to thank Trustee Stewart and Village Administrator Bambrick for the hours of work and advocacy they have put in over the past year on these issues.

#### **Queens Bus Network Redesign and Q110**

- During the middle of the year, the Village Board was informed that the Queens Bus Network Redesign project was proposing the Q110 to terminate at the Floral Park LIRR station while using Tulip and South Tyson Avenues as entrances to/from the station.

As we have always done, the Village Board researched the issue and, via letters and public meeting testimony, provided the MTA with reasonable arguments why this idea was not only full of logistical hurdles but, also, that it did not provide any meaningful service to their customers or our residents. In mid-December the MTA submitted the final plan and we were happy to see that the MTA heard our arguments and the Q110 will not be entering Floral Park.

#### **Belmont Park**

NYRA has continued work on their multi-year project to redevelop Belmont Park, which includes a brand-new Grandstand, 4 new racing surfaces including a new winter track, and a new backyard. As of late Fall, the entire existing grandstand has been demolished.

- Additionally, management at NYRA has kept us apprised of ongoing and coming milestones with the redevelopment including regular meetings (along with site visits) of the Belmont Park Advisory Board which both Trustee Chiara and I attend as members.
- I would like to also like to thank the team at the UBS Arena and Oak View Group for working with us and attending to any issues that have arisen since the arena has opened. They have not only responded to the few incidents that have occurred they have also reached out directly to the residents who were affected. We look forward to working with them in the coming year as the new mall opens up.

#### **Downtown Revitalization/NY Forward Grants**

Under the leadership of Deputy Mayor Pombonyo and Building Department Superintendent Marcus, the Village for the 4th year has submitted a grant application to New York State for improvements to our downtowns. This year we focused on and applied for the NY Forward grant specifically for the western end of the Jericho Turnpike corridor. For the first time since we have been applying for these awards, the Empire State Development Corp (“ESD”) and Long Island Regional Economic Development Council (“LIREDC”) invited us to a meeting in late November to present our application as well as answer questions from both the ESD and LIREDC.

As mentioned in previous years, even though to date we have not been awarded the one grant per year given out on Long Island, we continue to use this process to explore projects that come up during discussions so that we can move forward without the grant.

Additionally, we were excited to welcome a number of new businesses to the Village this year and it seems that restaurants continue to thrive here in the Village, especially in and around Tulip Avenue. We thank all of the new entrepreneurs that came to present at various Village Board meeting who risk their capital to bring not only needed services to the Village but also ones that are enjoyable that continue to enhance the community spirit.

### **Fire Department**

First, I would like to thank the men and women volunteers of the Fire Department for the countless hours they put in to serve our residents. Whether it be responding to call, training, or researching new equipment needs, we are grateful for their continued dedication to our residents and those who visit Floral Park. This year they responded to 1428 calls.

Separately the Chief's Office along with Trustee Chiara and myself continue to research, write comment letters or testify at public hearings on the national letter in opposition to the Occupational Safety and Health Administration's ("OSHA") newly drafted Fire Brigade standards. These new standards would, amongst many things, significantly increase annual training requirements and costs for volunteer fire departments across the country.

Lastly, the Reliance Engine Company has received its new truck that was years in the making and you should see it on our streets in the coming weeks. I would like to thank ex-Chief Hammerman, Chief Sangen and their new truck committee for their time spent in researching and conducting the significant due diligence on what was needed in the detailed specifications. I would also like to thank Assemblywoman Solages for obtaining a grant which will offset a portion of the total cost of the truck.

### **Police Department**

The Floral Park Police Department responded to more than 10,000 calls for service in calendar year 2024 and conducted more than 3,700 traffic stops.

Each day our police officers visit our Village schools while on patrol. To this end, the Department conducted more than 200 school visits divided among schools in the Village in 2024. Our four School Resource Officers, conducted seminars for school district employees in situational awareness and our department's response to incidents at the schools. Additionally, our School Resource Officers conducted anti-bullying, Halloween safety, pre-prom safety, social media safety, digital citizenship, and drug education lessons in our schools. They also conducted Operational Safe Child for several hundred children in the district.

The Department trained Floral Park Public library employees, and library patrons, on the use of Narcan.

It should also be noted that the Department transitioned to "Red Dot" sights on our duty pistols, which will improve accuracy and tactical advantages.

### **Trees**

Another asset of the Village that requires significant attention and, every so often, removal and replacement, are our Village trees. The Village is very proud of our trees and our "Tree City USA" designation. In order to maintain our "Tree City" designation, each year the Village has to apply to the National Arbor Day Foundation and provide significant data to show that the Village meets their requirements and that the Village takes our tree management and replacement seriously. Included in the data in this year's submission to the Arbor Day Foundation are the following facts from the past year: (i) the Village had to remove 100 trees for various reasons including a disease; (ii) we planted 300 new trees throughout the Village (and that does not include anything at Centennial Gardens); and (iii) the Village pruned 700 trees. As stated, our trees are a great asset and the Village is committed to responsibly preserving and maintaining them.

### **Best in Nassau County Awards**

Thanks to the dedication and creativity of our Library staff and Library Board, the Floral Park Library was once again voted "Best Library in Nassau County". Also, due to the tireless efforts of our volunteers, DPW and Parks teams, Centennial Gardens was named "Best Public Gardens in Nassau County".

### **Staying Up to Date**

Our E-Village Items is emailed usually every other Friday (the Friday after each Village Board Meeting). It covers the topics mentioned in the Mayor and Board of Trustees' Board Reports as well as updates on certain other events and projects taking place in the Village. It also contains links to upcoming hearings and meetings, such as Zoning Board of Appeals and Architectural Review Board. The E-Village Items is sent out to all on the Village's email notification list, which now contains more than 4,000 email addresses. 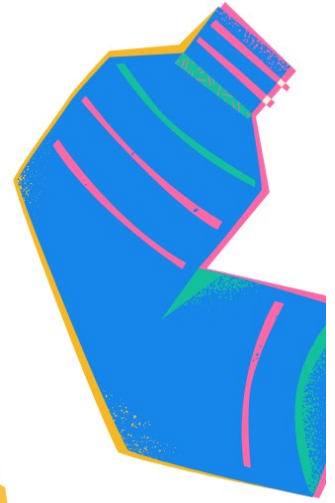


# 2024 CHRISTMAS FESTIVAL & TREE LIGHTING

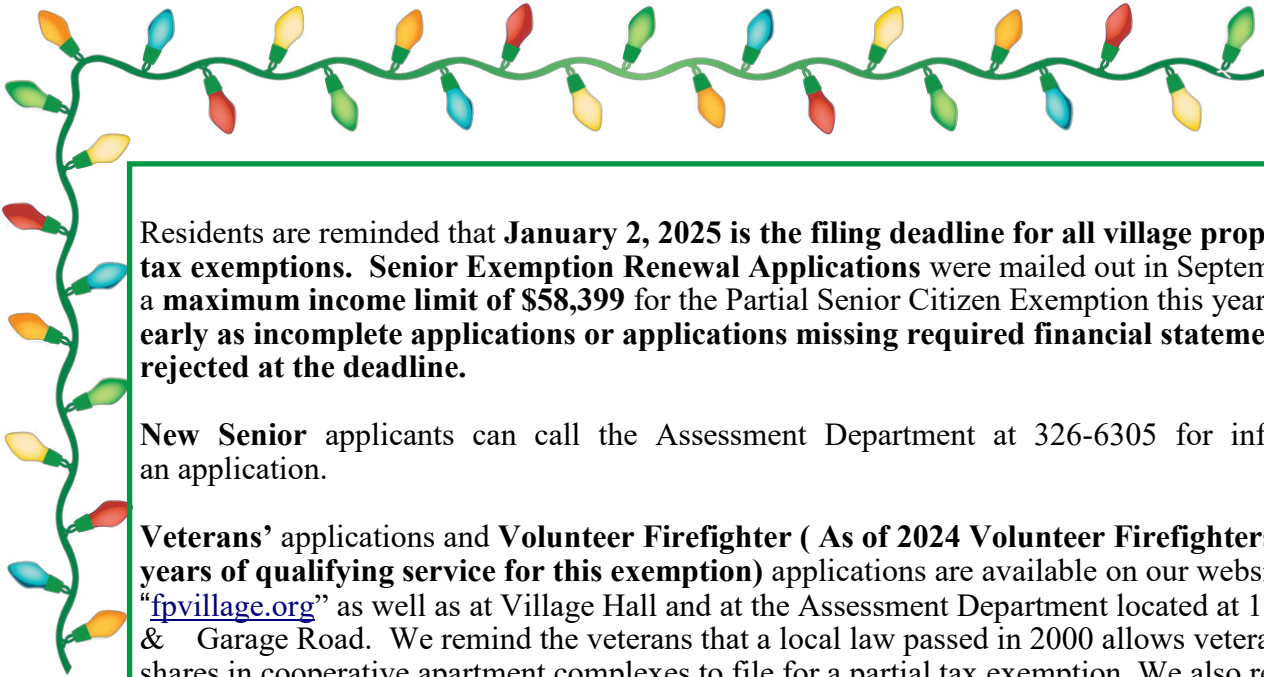

## ASSESSMENT DEADLINE



Residents are reminded that **January 2, 2025 is the filing deadline for all village property tax exemptions. Senior Exemption Renewal Applications** were mailed out in September. There is a **maximum income limit of \$58,399** for the Partial Senior Citizen Exemption this year. **Please file early as incomplete applications or applications missing required financial statements will be rejected at the deadline.**

**New Senior** applicants can call the Assessment Department at 326-6305 for information and an application.

**Veterans' applications and Volunteer Firefighter ( As of 2024 Volunteer Firefighters only need 2 years of qualifying service for this exemption)** applications are available on our website "[fpvillage.org](http://fpvillage.org)" as well as at Village Hall and at the Assessment Department located at 1 Pool & Garage Road. We remind the veterans that a local law passed in 2000 allows veterans who own shares in cooperative apartment complexes to file for a partial tax exemption. We also remind and encourage any veteran having a Disability Rating or a change in his or her Disability Rating, to contact the Assessment Department. **Change requests and new applications** must be submitted by the January 2, 2025 deadline.

If you are a **new property owner** in the village or you are a property owner who has a **mailing address change, bank change, or have satisfied your mortgage**, please contact the Assessment Department as soon as possible to update our records and direct future tax bills and correspondence to the correct address or bank.
